[2] ABEC Elevator recommendation is to completely bring all elevators to compliance without a complete modernization of every elevator. Total cost \$404,370.00

[3] TK Elevator did not provide Letters of Recommendation, as required.

[4] ABEC Elevator provided four (4) Letters of Recommendation. More than required.

[5] TK Elevator did not notarize Business Capability Form, as required.

[6] Premier Elevator DBA Elevated did not notarize Business Capability Form, as required.

[7] TK Elevator provided only a current Sample Certificate of Insurance and not a current listing Fayette County Public Schools as the Certificate Holder, as required.

[8] Premier Elevator DBA Elevated only provided current proof Certificate of Insurance but did not list Fayette County Public Schools listed as the Certificate Holder, as required.

[9] ABEC Elevator provided current Certificate of Insurance but did not list Fayette County Public Schools as the Certificate Holder, as required.

[10] TK Elevator is missing supporting documentation with bid submission.

[11] ABEC Elevator Regular Service Rate has a two (2) hour minimum

[12] TK Elevator Emergency Service Rate has a two (2) hour minimum

[13] ABEC Elevator Emergency Service Rate has a two (2) hour minimum
