- [5] Skyline Construction did not include three (3) Letters of Recommendation as required. Only two (2) were submitted.
- [6] Alpha Roofing provided references and surveys from previous vendors but no Letters of Recommendation as required. (3+ References submitted)
- [7] Ben Hill Roofing provided references but did not submit Letters of Recommendation as required. (3+ References Submitted)
- [8] Safe Roofing only provided two (2) references and did not submit Letters of Recommendation as required.
- [9] Skyline Construction provided a current Certificate of Insurance but did not list Fayette County Public Schools as the certificate holder.
- [10] Alpha Roofing provided a current Certificate of Insurance but did not list Fayette County Public Schools as the certificate holder.
- [11] Safe Roofing did not submit a Certificate of Insurance as required.
- [12] Safe Roofing only submitted half of the E-Verify Documents, which did not include the notarized portion.
- [13] CGS LLC did not provide Product Data as required.
